REQUEST FOR DIRECTION TO ALL THE SHO_s/SPO_s OF BIHAR TO ENSURE ARRESTS OF CUSTOMERS DURING BROTHEL RAIDS WHILE RESCUING CHILDREN FROM COMMERCIAL SEXUAL EXPLOITATION.

Brief Introduction about Justice Ventures International Project (in short JVI): JVI is a human rights organization dedicated to partnering with local organizations to secure freedom, justice and restoration for children, women and men suffering from human trafficking and other extreme injustice in India. Over the last over eight years our justice initiatives have directly impacted over 35,000 lives while strengthening the capacity of over 60 local justice organizations to serve thousands more on an ongoing basis. Among other accomplishments, JVI and its partners have assisted the local administration and law and enforcement agencies in rescuing over 4,800 human trafficking victims through over 160 rescue operations while providing vital legal services in over 300 ongoing legal cases to ensure over 200 of perpetrators involved in these cases are held accountable.

Human trafficking: Human trafficking is a global issue, with over 45.8 million trafficked persons worldwide, which is more than the people who live in the cities of London, New York, Seoul and Delhi combined. Worldwide, approximately 80 % of human trafficking victims are women and girls, and up to 50% are minors¹. As per the NCRB 2018 report, 1313 incidences of human trafficking are reported². According to the Trafficking in Persons Report 2018, the Govt. of India does not fulfil the minimum requirements for the elimination of trafficking; however, it is making significant efforts to do so.³ India is a source, destination and transit country for human trafficking, with 90% of the problem being internal, and those from the most disadvantaged social strata - lowest caste Dalits, members of tribal communities, religious minorities, and women and girls from excluded groups - are most vulnerable.⁴ The major forms of trafficking prevalent in India are: Sex Trafficking/Commercial Sexual Exploitation&Forced Labour.

Experts estimate millions of women and children are victims of sex trafficking in India. The Action research on trafficking conducted by the Institute of Social Sciences under the aegis of the National Human Rights Commission indicates that most of the police officers are not aware of the provisions of the law dealing with trafficking and again while registering cases of trafficking provisions of substantive law are not being combined with the provisions of special law i.e. ITPA. This very often allows the culprits to escape the clutches of the law with light or no punishment, especially - customers.

Legislations and deterrent provisions against trafficking: India has very strong deterrent laws to effectively curb this monstrous evil and most heinous crime. Following are the legislations which prohibit and prevent human trafficking. These are:

Measures to Take in Order to Deter the Accused:Despite Indian legislature has come up with numerous strong legislations in order to prevent trafficking in persons, however the Indian Legal System has blatantly failed in preventing the scourge of human trafficking and all forms of exploitation attached to the this horrific and diabolic crime. Most of the victims are from deprived and marginalized sections of the society and dysfunctional families and most of them are illiterates. They face harrowing times in the dirty brothels with no choice in deciding the

On ensuring customer accountability and deterrence thereby creating model sex trafficking cases, the following strategy can be very helpful to control and curb the organized crime:-

Arrest and Criminalization of sex buyers - customers: It's impossible to eradicate this organized crime from our society unless until the entire chain of criminals is broken. Apart from traffickers etc., the customers/sex buyers should also be brought to justice and should be dealt with iron hands of the law. It is often noticed that the customers/sex buyers who are the prime instigators and promoters of this heinous crime are not booked and they escape with impunity because the law is never/rarely enforced against them. Customers are part of organized criminal network. The sex buyers/customers demand for the sex and traffickers, agents, pimps, brothel managers/owners, etc. supply vulnerable victims to fulfil their lust for commercial gains. If the customers are booked and prosecuted, the deterrence will drastically reduce the monstrous and dubious crime of trafficking. Sections 370/372/373/376 of IPC, sections 5/6/9 of the Immoral Trafficking (Prevention) Act, Sections 75/81 of JJ Act and sections 4/6/8/10 of the POCSO Act, attract against the customers also.

Therefore, we would humbly request your good offices to consider our submission and direct all the SHOs/SPOs for ensuring arrest of customers in all future brothel raids while rescuing children from
